Review Harold Lindelof's Special Use application request to relocate a one- bedroom house from 70715 Oulu Rock Road to a 40-acre site at corner of Oulu Rock Road and Bain Road.

Special Use Permit application:

- ➤ 40-acre parcel
- ➤ Relocate a one-bedroom house from 70715 Oulu Rock Road
- Parcel is zoned Forestry 1

- ➤ Parcel size is 40 acres
- ➤ Parcel Future Land Use Class is Forestry Core
- Forestry Core allows the maximum density of 1 building unit complex per 35 acres
- ➤ The Special Use Permit application to relocate a house to this parcel is consistent with the Zoning Classification and the Future Land Use Class for the parcel.
