Proceedings of the Parks and Recreation Committee Monday, October 6, 2014, 5:30 p.m.

A regular meeting of the Parks and Recreation Committee was held on Monday, October 6, 2014 at 5:30 P.M. in the Conference Room #1, Second Floor, Memorial Building, Ironwood, Michigan.

1. Call to Order:

Chair Davey called the meeting to order at 5:30 p.m.

2. Recording of the Roll:

3. Approval of the Minutes:

Motion by Anderson to approve the September 4, 2014 Meeting Minutes. **Second** by Wamhoff. **Motion carried 7 to 0.**

4. Approval of the Agenda:

Motion by Anderson to accept the amended Agenda to include item 8e Little League Field Dumping and 8f Mt. Zion. **Second** by True. **Motion carried 7 to 0.**

5. Citizens wishing to address the Committee on Items on the agenda (Three-Minute Limit):

None

- 6. Citizens wishing to address the Committee on items <u>not</u> on the Agenda (Three-minute limit):

- 7. Park Financials none to present.
- 8. Items for discussion and consideration:
 - a. Capital Improvement Plan (CIP): Director Brown presented the CIP before the Committee. The City is required to approve and adopt a CIP each year, which consists of all physical projects that the City wishes to undertake, over the course of 5 years. The Planning Commission will review and make a recommendation to the City Commission, per State Statute. Director Brown has updated the CIP to list the priorities emphasized in the Parks and Recreation portion of the Comprehensive Plan. The CIP is intended to help guide the City Commission for the following year budget process. Director Brown advised the Commission to review the Parks and Recreation component of the CIP, for the next meeting. True mentioned that it might be good for committee members to discuss the CIP with Director Brown individually. Director Brown stated that the CIP will be reviewed by the City Commission in November and December.
 - b. Trail Priorities: Director Brown moved on to strategy 4.5 of the Comprehensive Plan, which is prioritize, plan and construct trail system improvements. The regional trail is the main spine of the trail system and other local trails to connect with the regional trail system. The committee is tasked with prioritizing the next area of the community to look at and focus efforts on. These efforts start with acquisition identifying public or private property and either purchase or have easements. Anderson stated that his first suggestion would be the river walk which is prime for development and to take advantage of the natural resource that is there. Davey stated that most of the river walk trail is laid out, with GCC and the City on board however, there is one section that will have to be worked out. Davey thinks that the first priority is to acquire a trail from the regional trail to Miners Memorial Heritage Park (MMHP). Davey indicated that the MMHP trail should be the first priority and that the river walk should be the second priority. Discussion ensued about the potential path from the regional trail to the miner's park. Anderson stated that adding pavement to a road would be more expensive opposed to creating a trail through properties. Kangas asked about the safe routes to school paths. Director Brown pointed out asphalt trails from the regional trail, directed toward the school. Director Brown will present a list of the publicly owned properties to help with acquiring the trails in the future. He would also like the motorized and non-motorized groups to have a meeting to hash out any issues that haven't been resolved. Once the plan is in place, it will be easier to discuss between the groups. The committee agreed that the short term plan is the link between the regional trail and MMHP and long term is the river walk. Director Brown also brought up some abandoned railroad grades that run south of the city that they may also be able to work on. Kangas brought up an easement given by Xcel Energy which could be a good route to the MMHP. Director Brown stated that this route will make the process longer but, would be a good route for the future.
 - c. Miners Master Plan extraction of natural resources: Director Brown stated that the MMHP group would work on the plan and run through the City. He then updated the Committee on a company that had requested the extraction of mine rock from the park. He would also like the

Committee to consider for future requests. Davey stated that it should be looked at by individual requests and the decision should fit into the plan. Discussion ensued on the topic.

d. Art Master Plan: Director Brown has been working the Downtown Arts Place (DAP) on the plan. The DAP have been the drivers of the plan which relates with Parks and Recreation. Director Brown would like Parks and Recreation to be the overseer of the plan. Burchell asked if all arts would be a part of the plan. Director Brown stated that it will be a comprehensive plan of all arts and culture in the community.

Motion by Davey to move forward with the Art Master Plan. **Second** by Anderson. **Motion** carried **7 to 0**.

e. Little League Field Dumping: Davey presented an agreement between the City of Ironwood and Snow Country Contracting that stated fill requirements when dumping behind the Little League Field. Davey stated that Ruotsala Concrete has been dumping on this location, violating the fill requirements presented to Snow Country Contracting. Semo passed out pictures of the dumping before the committee. He stated that he just wanted to investigate to provide information and present to the committee. Davey stated that Parks and Recreation has been against this from the beginning. Burchell stated that there will be a huge erosion issue in the future. Davey stated that Ruotsala is required to abide by the same rules which are not being enforced. Director Brown stated that he did bring this up at a staff meeting. The Committee discussed their deep disapproval of how this was taken care of.

Motion by Davey to make known that Parks and Recreation is very unhappy with the situation and that the problem needs to be taken care of and fixed, with an explanation as to why the dumping has taken place; the area should be in compliance with the contract with an acceptable grade, capped with acceptable top soil fill, seeded and mulched. **Second** by Wamhoff. **Motion carried 7 to 0.**

f. Mt. Zion: Davey updated the Commission on the progress with Mt. Zion. He had Beaver Tree Service provide an estimate to have brush and small trees removed at the top of Mt. Zion. The Ironwood Tourism Council (ITC) will pay \$400 for the project dependent on the City paying the additional \$400.

Motion by Burchell for the request that the City pay's \$400 contingent on the ITC approval. **Second** by True. **Motion carried 7 to 0.**

Burchell left the meeting at 6:27pm.

9. Project Updates:

- a. Comprehensive/Park and Recreation Plan Implementation Status: Director Brown updated the committee on the progress of the plan.
 - i. Master Plan for the Miners Park, which the Committee discussed.
 - ii. Art Park, which was discussed.
 - iii. The Depot park plan. They have applied for a playground through a DNR Trust Fund grant. Director Brown had received preliminary scores this month.
 - iv. Trail Priorities were also discussed.

10. Other Business:

- a. Director Brown will not be at the December 1st meeting and he will update the Committee closer to the date of the meeting, if there will be a December Meeting.
- b. Davey updated the Committee on a Haunted House at the Historic Ironwood Theatre.
- c. Kangas would like to thank Neil Corcoran for filling the pot hole on the top of Mt. Zion.
- 11. Next Meeting: November 3, 2014 at 5:30 p.m.
- 12. Adjournment: **Motion** by True to adjourn the meeting. **Second** by Anderson. **Motion Carried 7 to 0.** Adjournment at 6:33 p.m.

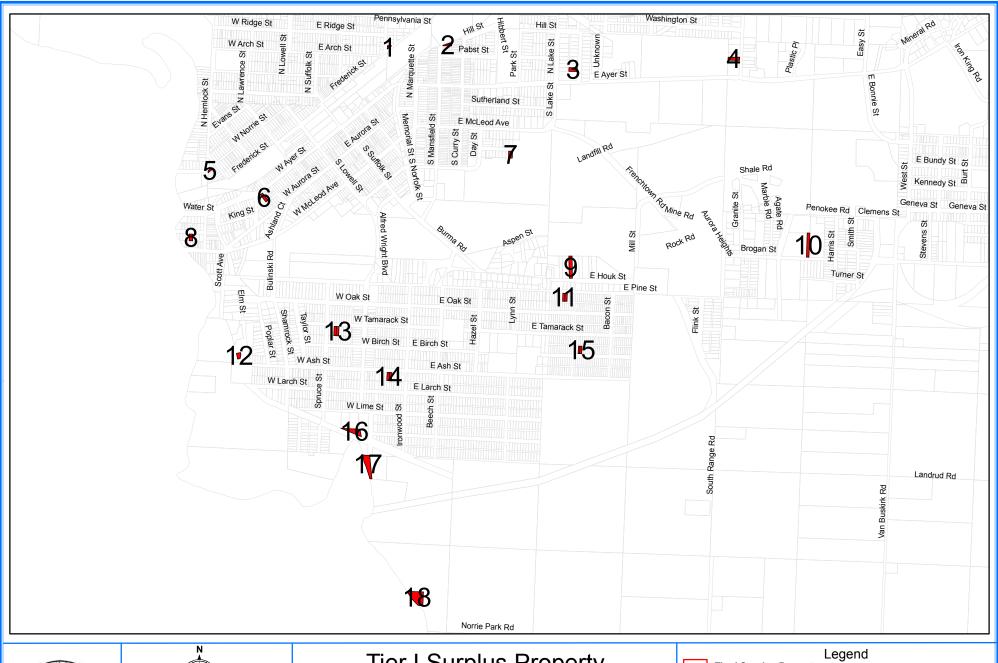
