- 8. Items for discussion and consideration:
 - a. Trail Summit Follow Up: Director Brown updated the committee on the previous trail summit and presented the current proposed trails for motorized trails in relation to non-motorized trails and school property. Director Brown will follow up with the major groups to solidify a plan, to present to the Parks & Rec Committee.
- 9. Project Updates:
 - a. Comprehensive/Park and Recreation Plan Implementation Status: Director Brown updated the committee on the progress of the plan. Davey brought up two new items: 1. To focus attention on the river walk which would be easy from his perspective and 2. For the City to purchase the land from all of the abandoned rail grades. Discussion followed. Director Brown mentioned that priorities were already agreed upon from last meeting and the Comprehensive Plan.
 - b. Dog Park Status: Director Brown updated the Committee with his conversation with the airplane group. Davey brought up a discussion he had with HOPE and the Miners Memorial Heritage Park group of creating the dog park on the corner of Bonnie and Ayer.
 - c. Grant Status: Director Brown updated the committee on the following items:
 - i. Art Park: Successfully obtained funding.
 - ii. Regional Trail: Construction begins in 2015.
 - iii. Longyear Park: Bid specs are into the DNR for review.
 - iv. Depot Park: Applied for DNR Trust Fund grant and have been recommended by the DNR.
 - v. Curry Park: Applied for DNR Trust Fund grant and have been recommended by the DNR.
- 10. Other Business:
 - a. The Committee discussed future potential projects to consider. The projects to consider were a basketball court, natural playground, and outdoor skating rink at the Depot Park Volleyball Courts. The Committee did choose to prioritize trails at the previous meeting. Kangas requested Director Brown to ask for Downtown Ironwood Development Authority support for an outdoor skating rink at Depot Park.
 - b. True had requested a committee to review alternate dumpling locations for highway materials to divert dumping away from the park.

PARKS ACTION PROGRAM

This section provides guidance on improvements for the next 6 years in Ironwood. This program is based in the community feedback and ideas generated as part of the 2014 Comprehensive Plan.

Focus for the action program is on:

- Implementing the trail plan and creating connections to regional trails and loops
- Signage and wayfinding
- Facilities to meet the community's needs and desires
- Recognizing the costs associated with maintenance
- Continuing the dialogue with the community to ensure parks are meeting the needs of residents and goals outlined in the plan

At the end of each year, the city should go through the checklist to see what they were able to accomplish. Inevitably, some new projects will arise, and others will slide into the next year. As part of the annual checklist there should be a self evaluation of how well we did implementing the plan and why there were successes or struggles.
