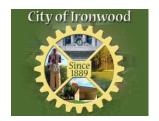

**Date:** 4 June 2014

At our next meeting on Wednesday, we will have 1 hour. In that hour it is our objective to cover the following:

#### 1. Project Status Update

Since the May Planning Commission meeting, the City hosed an open house to review the Comprehensive Plan Draft. A meeting note/summary document is attached for reference purposes. The plan has also been posted on the project website with a comment form. To date, we have received one set of comments through the web site. We have also received some comments/suggestions on the vision statement which will be discussed below. We will provide an-up-to-date download of comments received at the meeting on Wednesday.

#### 2. Discuss comments received and reflections from the meeting

Based on your attendance at the meeting and further reflection on the draft plan, the remaining portion of the agenda is intended to discuss any final changes that should be made to the draft document prior to the public hearing in July. The following key "content" related topics are of note from staff:

- Vision At the last meeting, the PC spent considerable time discussing the vision statement. PC members were charged with recommending some language for consideration. A community member has offered some suggestions that include emphasizing more strongly trails, small town, rural, quality of life, and deleting the last paragraph all together. Staff will present any further comments received between now and the meeting on Wednesday. Please be prepared to discuss and agree on the language for the Vision.
- City owned vacant parcels staff is looking at strengthening reference to strategy 6.11 (c) (and related to strategy 3.3) to provide better guidance on disposing of surplus property. The principle is to place parcels into one of two categories: category 1 would include smaller, more isolated parcels that are most appropriately added to adjacent private parcels and category 2 would include larger contiguous parcels or parcels that present stronger redevelopment potential that would be disposed of through an RFP process.

• Other minor changes have been identified including: changes to figure 4.1 Street Network to reflect the current functional class and clarification to figure 4-6 motorized system to note that if a street is not restricted it is open for motorized use.

Approximately 30-40 minutes

#### 3. Next Steps

The Planning Commission public hearing is set for July 2<sup>nd</sup>. Our intent is to make a final round of edits in preparation for the Planning Commission Public hearing and produce a 'public hearing draft' document. Following the public hearing, staff will be requesting the Planning Commission to take formal action on the plan. A resolution of adoption, with any recommended changes, will be forward to the City Commission for action on July 14<sup>th</sup>.

# Ironwood Comprehensive Plan Update 5/19/2014 Community Open House Summary

**Date of Meeting:** May 19, 2014, 4:30 to 6:30pm

**Location:** Memorial Building Auditorium

Number of Attendees: 27 who signed the sign in sheet. A few participants were observed who

did not sign in.

**Overview:** Copies of the draft plan materials were made available to browse and comment on. A series of presentation boards were displayed around the room providing summary materials of each chapter of the plan document. Post it notes and comment cards were provided to participants to comment on the draft plan.

Staff (Brad Scheib and Michael Brown) were available for question and answers as were various members of the Planning Commission and City Commission during the course of the meeting.

Two comments were recorded on the boards using post it notes. Those included:

- Additional school planning
- Senor Care Centers "life cycle"

No comments were submitted on comment cards.

**Discussion Points:** The following points of discussion were observed during the open house by various attendees:

- 1. The strategies will need to be prioritized. How this is done will be difficult. How can community members influence or affect the prioritization of strategies?
- 2. The strategy matrix identifies "Potential Partners" as a column. This could be filled out more add Ironwood Tourism Council/Convention and Visitors Bureau as a partner where appropriate.
- 3. Residents expressed interest in park improvements at various parks. (Specific request to improve Little League Field.)
- 4. Support for wayfinding was expressed, particularly street signs, as a possible priority.
- 5. Trail user forum is an important idea and one that users are trying to coordinate already.
- 6. Strategy 6.7 (encourage events and festivals) is a good strategy that is sort of being done but could be enhanced by better organization and commitment. Discussed ideas of collaborating with the Gogebic Community College to leverage other people resources for expertise. Who should lead this effort?
- 7. Economic development is important. Idea of picking 10 niche markets (for example: lumber/wood products, outdoor recreation, arts and culture, medical, etc.) to focus on provide diversity but also provide focus.
- 8. Coordination and collaboration among overlapping or abutting jurisdiction is a critical need. Dealing with annexation will always be a challenge.

- 9. Housing in downtown is an interesting concept as are other uses that might better utilize some of the great spaces in downtown.
- 10. Appreciation was expressed for references to survey responses and trying to respond to all community concerns.
- 11. A suggestion was made to provide a list of key definitions and acronyms somewhere in the plan (or in call out boxes throughout the plan) to define terms that are not customary.

**Going Forward:** The plan is made available on-line with ability to provide comments through July 2<sup>nd</sup> which is the date of the Planning Commission Public Hearing. Comments are encouraged to be submitted the week before the Planning Commission public hearing.

The City Commission is expected to consider the plan at its meeting on July 14<sup>th</sup>.

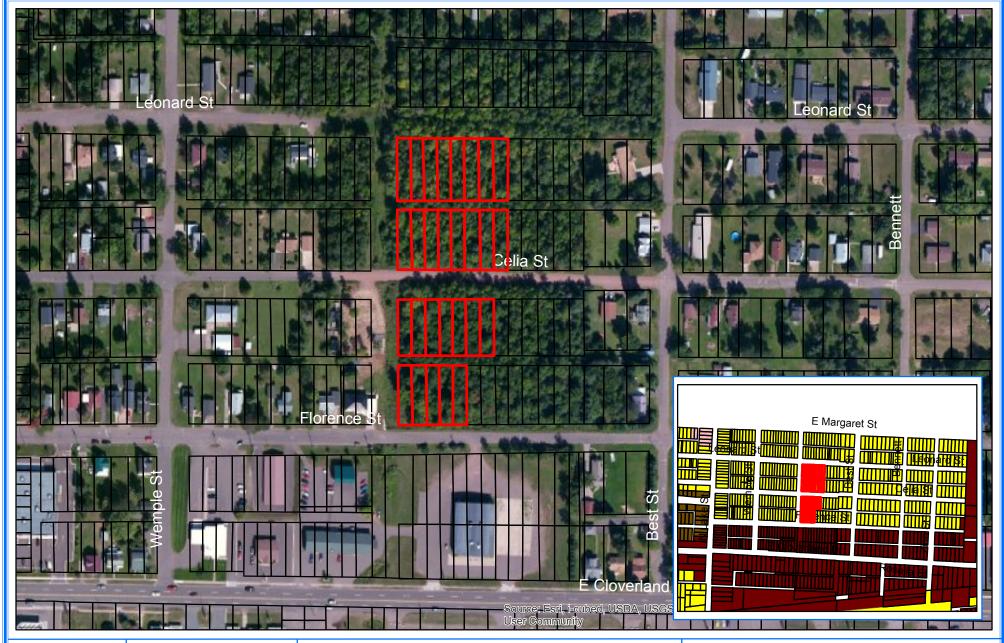

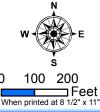
Re: 2014-006 Surplus Property Purchase Request

Staff recommends taking no action at this time.

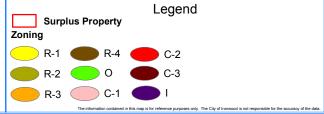
