Dear Sirs:

I am currently named as a garnishee in the above matter designated as such by, primarily, the appearance of Exhibit A, two (2) notes or letters not witnessed by anyone, which I Stephen Beizer do state that I do owe the defendant Gene Steinberg significant sums of money for help which he did afford my family during very difficult and stressful times & circumstances. However, the letters/notes dated 3/31/11 and 4/22/11 respectively were written during a period when my family was facing eviction from the apartment we had resided in for seven years and we had no alternative place to be... entre Gene Steinberg, my brother-in-law married to wife's only sibling, sister Barbara for about 35 years and, Gene proceeds to offer "help" in lifting our pending burdens of rent and utilities in return for a note acknowledging our indebtedness to him - 3/31/11 A note which he dictates and I write and sign... to him - 3/31/11 A note which he dictates and I write and sign...
