

Access to May 28, 2020 City of Ironwood Commission Budget Work Session Zoom How to Instructions for Participants

Access by Computer, phone, or tablet

1. Visit www.cityofironwood.org and click on the Join Zoom Meeting PDF to see log in information.
2. Click on the link to join the meeting or go to join.zoom.us on any browser and enter the Webinar ID provided below.
3. Your web browser will prompt you to join the meeting and to download zoom. Either click cancel to continue to join the meeting in your web browser or choose to download the zoom application.
4. After installation of the zoom app or by joining by the browser, you will be an attendee in the meeting.

Access by Telephone.

1. On your phone, dial the teleconference number provided below.
2. If you are disabled and in need of 711 services, please dial 711 to access the meeting and then using the teleconference number below.
3. Once dialed, you will be prompted to enter the webinar ID number followed by the # sign.
4. After entering the webinar ID number and the pound sign, you will again be prompted to select the # sign again.

Public Comment.

The first public comment opportunity will be under agenda item H, "Citizens wishing to address the Commission on Items on the Agenda (3-minute limit)".

The second public comment opportunity will be under agenda item I, "Citizens wishing to address the Commission on Items not on the Agenda (3-minute limit).

The public's microphones will be put on mute until the public comment period comes up, in which a citizen wishes to address the City Commission.

Each public comment period will allow individuals using computers, smart phones, tablets to "raise their hand" to let the administrator know if you would like to make a public comment. The administrator will unmute the microphone to provide the citizen the ability to state their name/address and follow up with their comment or question.

For attendings using a dial in phone, each individual will be asked by the administrator if they would like to make a comment during each of the public comment opportunities. The citizen can then provide their comment or question at that time.

The person speaking is asked to speak clearly into their microphone or telephone and to make their comments in a respectful manner.

There will be a three (3) minute limit for each public comment and at the end of the three minutes the speaker will be allowed to finalize their comment or question.
