1. Save money on State and Local Taxes

Saving hundreds of dollars by signing up as a medical marijuana patient could help you save hundreds of dollars. Taxes for recreational use attract tax rates that are higher for local and state taxes through an excise tax of 15% and other sales tax. Having a medical marijuana card can save you up to 25% of your purchases as the taxes don't usually apply for medical uses. As time passes this savings could enable you to buy more of your preferred strain for less.

2. Access to better dispensary services

It took a long time to issue licenses for recreational marijuana dispensaries. According to the Oklahoma Bureau of Cannabis Control The state has licensed recreational weed stores in operation. It is five times more than the amount of medical marijuana licensed dispensaries. This could limit your choices because most online stores and cannabis delivery services require you to have an MMJ card. 3. Lower Age Requirements

To purchase legally-purchased marijuana from licensed dispensaries, recreational users must be at least 21 years old. The minimum age to obtain the Oklahoma cannabis medical card is 18 years old. A medical marijuana card could make it easier for users to access cannabinoid supplements which can ease discomfort if you're aged between 18 and 21.

4. Additional Legal Protections to Carry

The latest Oklahoma recreational laws limit you to carrying 1 inch of marijuana. It is only possible to cultivate six mature plants or twelve immature ones. You are allowed to have up to 8 ounces marijuana when you possess medical marijuana cards. The MMJ card will give you protection when traveling with marijuana in your possession.

5. Access to more clean, potent strains

Because of the strict rules regarding medical marijuana, a majority of marijuana dispensaries require medical cannabis varieties to be subject to greater tests and verification than the ones intended for use in recreational settings. You can also access an array of cannabis products varying in the strength, THC and CBD ratios, and potency. A medical card allows you to purchase much more powerful strains than ones used for recreational use.

Although recreational marijuana is legal in Oklahoma, it's not yet legal to purchase cannabis for personal use. But, you must not abandon the medical marijuana card you have. It could take as little as 15 minutes for your physician's recommendation. If you are able to spend less and you'll be able to get better cannabis varieties.
