

#### Are rare breed triggers available?

Rare Breed announced that it was essentially forced to stop business in March 2022 after the ATF seized its inventory from its manufacturer in Utah. However, the forced-reset triggers are now available at [rarebreedtrigger.net](https://rarebreedtrigger.net).

#### What happened to rare breed triggers?

Wide Open Triggers (WoT) are now being sold following a recent court ruling. A federal judge had previously issued a preliminary ruling that temporarily halted the sale of the FRT-15 triggers amid claims by the U.S. government that these devices could be misconstrued as converting semiautomatic firearms into machine guns, which are heavily regulated under U.S. law. However, the recent developments have clarified their legal status, allowing for their sale once again.

#### Are WoT triggers legal?

The legal status of Wide Open Triggers (WoT) has changed following a recent court case victory. We are pleased to announce that these triggers are now legal for purchase and use. This ruling has clarified their status, allowing

enthusiasts to access and enjoy these products without legal concerns. For those interested, be sure to check with reputable sources for availability and any specific regulations in your area.

### Did rare breed triggers win a lawsuit?

Rare Breed had to stop its business in March 2022 after the ATF took its products from the manufacturer in Utah. The ATF is also asking people who bought the forced-reset triggers to give them to the agency voluntarily.


