I, Bobby Money, am happy to announce my candidacy for the office of Mayor, City of Flemingsburg.



## SEPTEMBER IS CITY **GOVERNMENT MONTH**

City Government Month is a grassroots awareness campaign of the Kentucky League of Cities that helps to educate the public about importance of local government. City Government Month strives to connect both elected and appointed city officials with their local school principals, teachers, and children, all while furthering social studies academic standards for the state. The program has the goal of making civics education fun and engaging. The program is designed for grades third through fifth but could easily be adapted for any grade level. The lessons are tied directly to the Kentucky statewide learning goals and academic expectations. An interactive map in the "Kids Zone" of the website allows students to explore city services and learn more about what cities provide. City Government Month has two primary goals:1. To educate elementary school children about the services offered by their city; and 2. To increase public awareness of local government services. The City of Flemingsburg has provided classroom materials to the Flemingsburg Elementary School to be used in implementing these lessons in the curriculum there. At its September meeting, the Flemingsburg City Council passed a resolution in support of this program and designating September as "City Government Month" and Mayor Marty Voiers has issued a proclamation to that effect.
