SCOPE OF WORK

This bid consists of supplying, loading, and delivery of 2,000 tons of Winter Street Sand.

Prior to a Notice to Proceed an independent laboratory chosen by the City of Ironwood shall verify the material meets specifications. Material testing will also be required on a random basis. Material testing costs will be paid by the City of Ironwood. All failed samples and repeat samples shall be paid by the contractor.

A computerized, certified and approved scale and larger fork shall be used to properly weigh every loaded truck. The approved contractor <u>shall</u> use a certified scale. Any cost associated with utilizing a certified scale shall be included in the bid price. An individual trip ticket for each load shall be provided and delivered to the Department of Public Works garage daily. *All bids <u>shall</u> include any cost to utilize a certified scale*.

Delivery shall be completed by October 31, 2019 with no deliveries on weekends.

SPECIAL PROVISIONS

1. Consideration of Proposals

(a) One Contract will be awarded to the lowest responsive and responsible bidder based on the total bid price for all items. The City reserves the right to accept or reject any or all bids and to waive technicalities as may be deemed best for the interests of the City of Ironwood.

2. Requirements for Performance Security and Payment Security.

(a) Upon completion of project the contractor shall provide lien wavers from all contractors and suppliers.

3. Commencement, Execution and Completion of Work

- (a) The Contractor shall be required to complete work under this Contract by October 31, 2019.
- (b) Execute the work diligently.
- (c) Working hours are between 7:00 A.M, and 4:00 P.M. (M-F)
- (d) No work shall be done on Saturday's or Sunday's.

4. Failure To Complete Work Within Contract Time

If the Contractor <u>fails</u> to prosecute the work, or any separate part thereof with such diligence as will insure its completion within the time specified in this contract, fixed and agreed Liquidated Damages in the amount of \$100 a day will be assessed for each calendar day of delay until the work is completed and accepted.

BIDDING REQUIREMENTS, CONDITIONS AND CONTRACT ADMINISTRATION

Competency of Bidders

The City Manager reserves the right to select bidders and may refuse to issue a proposal to any individual, partnership, firm or corporation based upon but not limited to one or more of the following facts:

- (1) For having defaulted on previous contracts.
- (2) For having preformed similar work in an unsatisfactory manner.
- (3) When in the City Manager's judgment the bidder does not have the required experience in the class of work bid on, fails to have the proper labor and equipment, or <u>fails</u> to have sufficient capital or quick asset to finance the work.

Delivery of Proposal

Each proposal must be submitted in a sealed envelope with the bidders name and address on the outside of the envelope. All proposals must be received on or before the hour stated in the advertisement. More than one proposal for the same project from an individual, partnership, firm, or corporation will not be considered. Faxed bids shall not be accepted.

Public Opening of Proposals

Proposals will be opened publicly and read aloud at the hour, date, and place set in the advertisement.

Execution of Contract

Upon receiving and reviewing required bonds a Notice to Proceed will be issued along with a City of Ironwood Purchase Order.

REQUIRED INSURANCE

- (a) Workmen's Compensation Insurance The Contractor, prior to the execution of the Contract, shall file a certification that the Contractor carries Worker's Compensation Insurance.
- (b) Bodily Injury and Property Damage Insurance The Contractor prior to execution of the Contract, shall file with the City of Ironwood copies of completed certificates of insurance, as evidence that the Contractor carries adequate insurance to afford protection against all claims for damages to public or private property and injuries to persons, arising out of and during the progress of work. The minimum limits of insurance shall be as follows:
 - (c) General Liability

Bodily Injury and Property Damage Liability:

Aggregate.....\$2,000,000

(d) Automobile Liability Insurance (Comprehensive Form)

- (e) The requirements for 1 and 2 above, may be met through an Umbrella Policy.
- (f) Owners Protective Liability. Bodily injury and property damage protection, including general supervision of work performed, shall be extended to the City of Ironwood employees and agents. The minimum limit shall be \$1,000,000.
