
MONTHLY FEES AND CONTRIBUTIONS

There is a \$50 representative sign up and renewal fee each year. The \$50 fee will be due on your anniversary date. Then there are the fees below.

We pay small fees and contributions monthly or annually for the services that Juice Plus+ provides for our Virtual Franchise and for the Juice Plus+ Foundation:

WEBSITES

For our websites – www.juiceplusvirtualoffice.com and www.juiceplus.com (personalized) subscription fees are automatically deducted from your paycheck each month. Fees are on a sliding scale, and are determined based on your title:

- New Representatives – FREE for the first 90 days
- Direct Distributors – \$5.00/month (after their first 90 days)
- Virtual Franchisees – \$12.00/month
- Sales Coordinators – \$15.00/month
- Senior Sales Coordinators – \$20.00/month
- Qualifying National Marketing Directors – \$25.00/month
- National Marketing Directors – \$30.00/month

All levels receive the same great Virtual Office benefits, including a personalized JuicePlus.com website.

CUSTOMER CARE

For all the work that The Juice Plus+ Company does in looking after our customers (from the time the order is entered) – note that Dealers are exempt – all DD's and VF's are charged a Customer Care fee of \$5.00 per month (automatically deducted from your paycheck each month), and all SC's through NMD's are charged \$10.00 per month since their customer base is so much larger.

CHARITABLE GIVING

In the spirit of *Inspiring Healthy Giving Around the World*: at the Virtual Franchisee level or higher, ½ of 1% (.5%) of bonus and commission earnings will be deducted from the Juice Plus+ Company check each month to support the charitable activities of The Juice Plus+ Foundation. This percentage will be deducted automatically, unless the Representative chooses to opt out of this deduction. FAMILY HEALTH STUDY

While The Juice Plus+ Company covers the majority of the cost of this program and the free product, we each make a small **contribution** to fund the Study. The **chart** below shows more detail.

2018 NEW FAMILY HEALTH STUDY YEARLY DONATION BREAKDOWN

- If you are a Dealer (at 0%, earning RSP only), your contribution is \$12.00 (for the year) with \$4.00 deductions for three box cycles.
- If you are a Direct Distributor (at 6%), you contribute an additional \$3.84 (for the year) total = \$15.84 (\$12.00 + \$3.84)
- If you are a Virtual Franchisee (at 14%), you contribute an additional \$5.19 (for the year) total = \$21.03 (\$12.00 + \$3.84 + \$5.19)
- If you are Sales Coordinator or higher (at 22%), you contribute an additional \$5.19 (for the year) total = \$26.22 (\$12.00 + 3.84 + \$5.19 + \$5.19)
